# Humanitarian Situation in July:

- Continued bombardment and killings using various methods and means, resulting in more martyrs and increased numbers of injuries, including amputations, burns, and permanent disabilities.
- The continued Israeli threat to evacuate Gaza. An increase in forced evacuation orders, resulting in more than two million Palestinians being confined to an area less than 45 square kilometers. According to OCHA, 88% of Gaza's territory is now designated as Israeli military zones or under evacuation orders.
- The ongoing blockade by the occupation, including the closure of crossings and the prevention of humanitarian aid from entering the Gaza Strip, has further exacerbated the suffering of civilians and their living conditions, while also weakening the ability and efforts of humanitarian organizations to respond to the needs of those affected and reach them.
- With starvation worsening and under mounting international pressure, the Israeli occupation authorities announced the resumption of humanitarian aid deliveries to the Gaza Strip by air and land on July 26, 2025. However, the occupation authorities have only allowed the entry of very small quantities of aid from some international humanitarian organizations, which represent a drop in the ocean compared to the growing needs of the population. Unfortunately, most of this aid has been looted by armed groups in areas under Israeli occupation control.
- Targeting civilians waiting for aid on their way to or near the distribution centers of the "Gaza Humanitarian Foundation" has resulted in over 1,330 aid seekers being killed since May.
- Intensifying hunger and malnutrition among all segments of society due to the systematic starvation policy practiced by the occupation authorities, with an increasing number of deaths reported daily. According to the World Health Organization, 63 deaths due to malnutrition were recorded in July.
- The water crisis continues due to the Israeli occupation's destruction of infrastructure and water networks.
- Airdropped aid poses a threat to civilians' lives and has resulted in the deaths and injuries of many. This method also violates humanitarian principles, as the distribution is unfair and excludes the most vulnerable and needy groups, in addition to failing to meet the massive needs within the Strip.
- Near-total paralysis in various essential sectors, most notably the healthcare sector, which is facing total collapse. Many hospitals and clinics have ceased operations due to direct destruction, lack of fuel and basic supplies, or being located within evacuation zones.
- Systematic targeting of humanitarian workers, absence of any real protection for them, and obstruction and delay of their humanitarian missions.

# Key Events of the PRCs in July:

- On July 1st, the occupation forces lifted the restrictions on the movement of the Palestine Red Crescent (PRCS) teams to and from Al-Amal Hospital and Complex, despite the difficult security situation in the area and its exposure to targeting. The teams started using a designated route to and from the complex without the need for prior coordination.
- On July 4th, two emergency medical technicians (EMTs) sustained minor injuries from shrapnel caused by a drone strike in Jabalia while performing their humanitarian duty.
- On July 8th, an EMT sustained a broken hand as a result of being targeted while performing his humanitarian duty in a neighborhood between Sheikh Radwan and Jabalia.
- On July 10th, an EMT and a colleague from the International Committee of the Red Cross (ICRC) were injured during a coordinated operation to evacuate a wounded person in Al-Bahliyah area in Khan Younis.
- On July 5th, colleague Mohammad Naseem Hijazi, who works in the security department in Al-Mawasi Field Hospital, went missing while on his way to check on his home in Al-Katiba area in Khan Younis.
- On July 8th, operations were suspended at the Al-Zaytoun clinic in Gaza city due to the security situation and the targeting of the surrounding area.
- On July 12th and 23rd, Al-Amal Hospital sustained significant damage to its Intensive Care Units (ICUs), clinics, and operating rooms (ORs) as a result of strikes on the hospital's vicinity, though no casualties were reported.
- Work continues on expanding and developing medical services in Al-Mawasi Field Hospital in western Khan Younis, including the addition of an ICU during the second week of July.
- Al-Mawasi Field Hospital in Khan Younis began to be used as a gathering point for patients traveling abroad, where they stay overnight to prepare for evacuation the following day in coordination with the World Health Organization (WHO). During July, the hospital received 306 patients along with their companions traveling through Karem Abu Salem crossing to receive treatment outside the Gaza Strip.

## Emergency Medical Services

- The teams evacuated (631) martyrs.
- They provided first aid services to approximately (8,663) cases, including injuries from shelling and emergency medical conditions.
- The teams assisted in the medical evacuation of (10) patients and injured in addition to (10) companions for specialized treatment abroad.

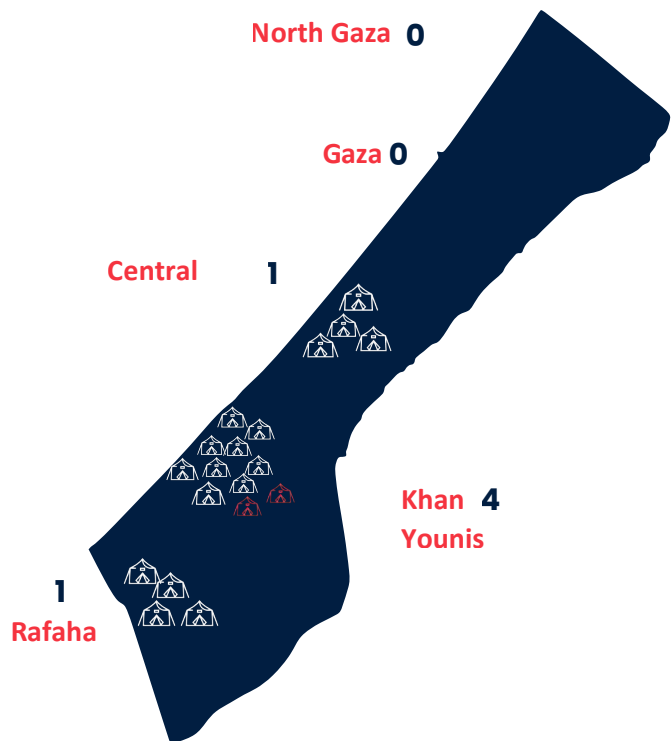
## Shelters

These centers accommodate approximately (2,202) individuals.

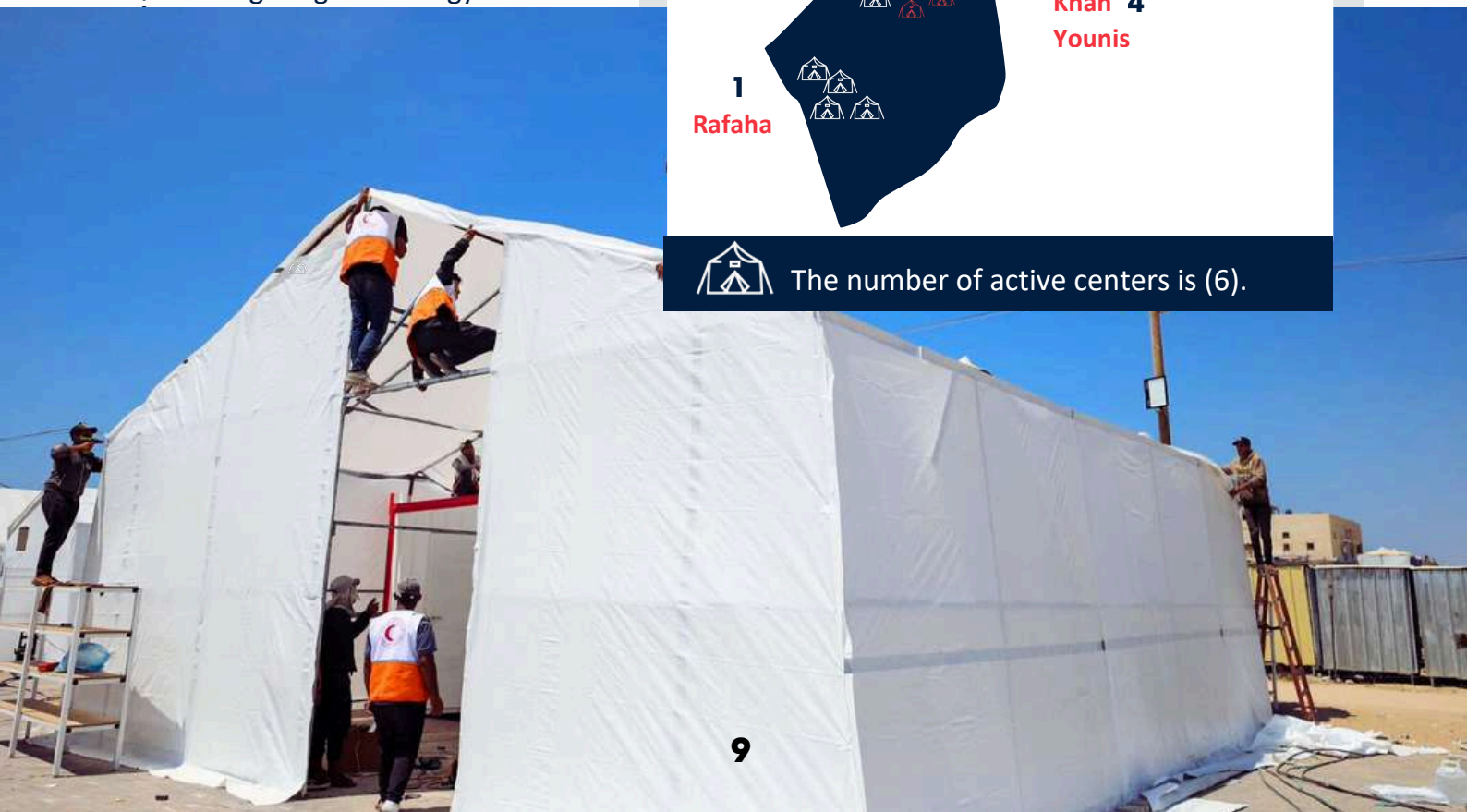
PRCS teams provide the following services to families residing in these shelter centers:

## Water, Sanitation, and Hygiene

Affected communities are provided with safe drinking water, access to save and inclusive sanitation facilities and hygiene supplies

- The actual daily production of the four water treatment plants in Gaza and Khan Younis reached approximately 66,000 liters of treated water. These plants are unable to function at full capacity due to various logistical and operational constraints (The full capacity production of the 4 is 160,000 liters).

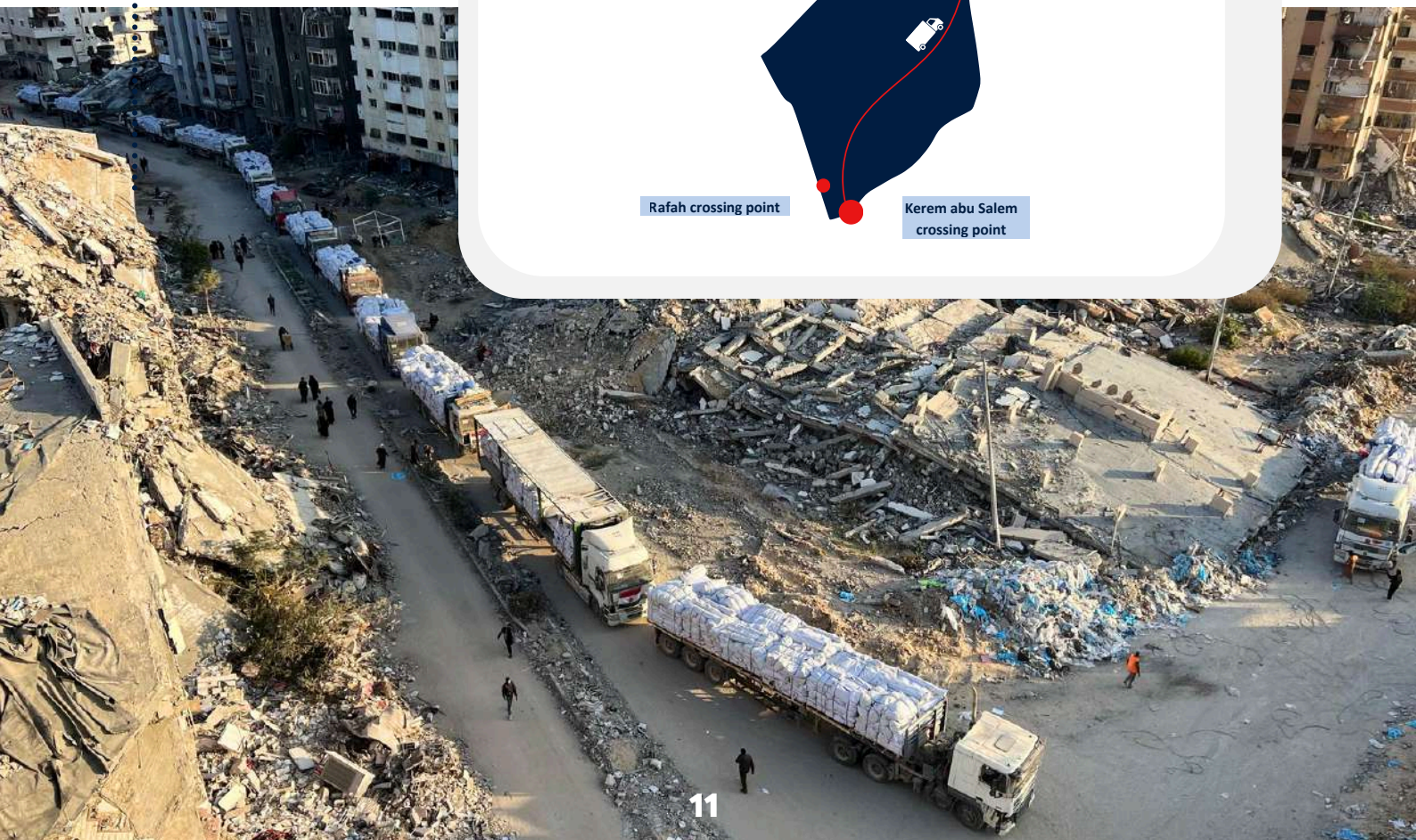
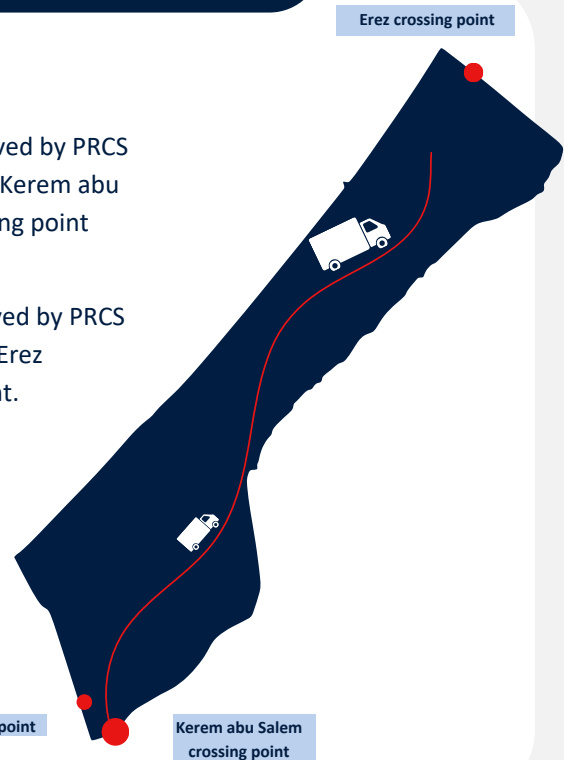
## Relief Aid Trucks

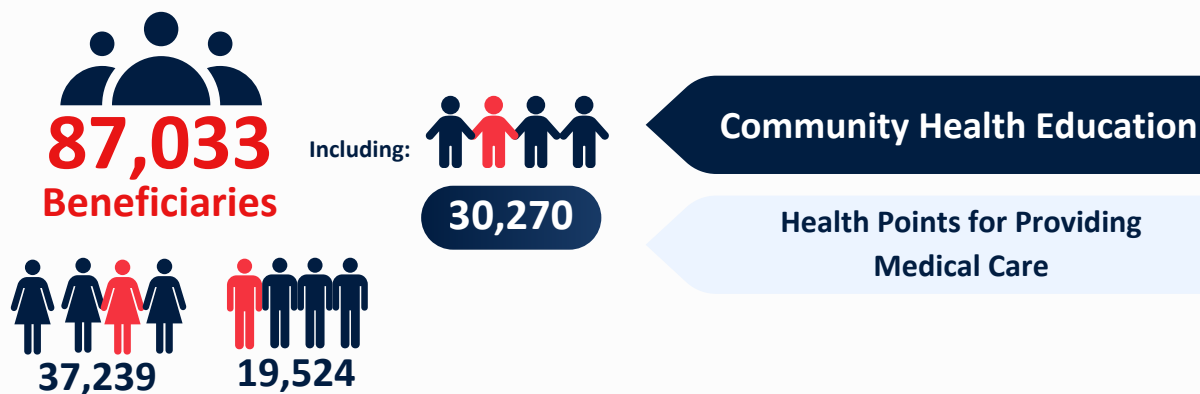

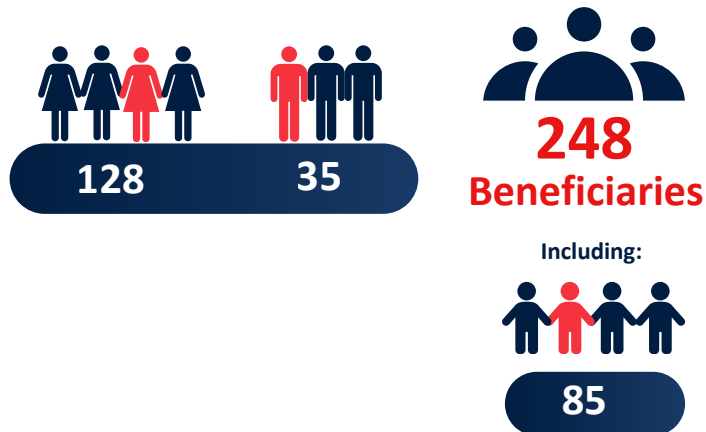






## Psychosocial Support

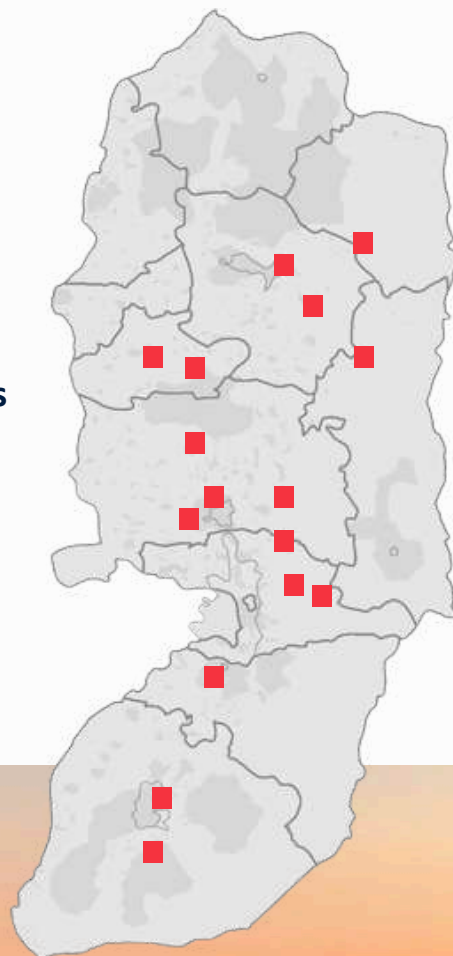
